

## Release of Claims and Myers Cave Resort Rules

In consideration of the use of the resort at the discretion of the Releasee with explicit permission for each visit to said resort, the receipt and sufficiency of which consideration is acknowledged, I \_\_\_\_\_ (Name) - (the 'Releasor' - Guest) of

releases and forever discharges Myers Cave Resort (Z-Spec Inc) (the 'Releasee') of 2471 HWY 506 Cloyne ON K0H 1K0, their directors, heirs, executors, administrators, legal representatives and assigns from all manner of actions, causes of action, debts, accounts, bonds, contracts, claims and demands for or by reason of any damage, loss or injury to person and property which has been or may be sustained as a consequence of residing, at such resort address 2471 HWY 506 Cloyne ON K0H 1K0. The Releasor acknowledges that this release is assumed for any person or persons under the legal age of 18, under the direct or indirect care of the Releasor.

For the above noted consideration the undersigned further agrees not to make claim or take proceedings against any other person or corporation which might claim contribution or indemnity under the provisions and any statute or otherwise.

It is agreed that this form is not an admission of liability on the part of Myers Cave Resort.

It is declared that the terms of this settlement are fully understood; that the type of consideration stated is the sole consideration for this release and that the use of the resort is accepted voluntarily for the sole purpose of making a full and final compromise, adjustment and settlement of all claims for injuries, losses and damages resulting or which may result from the above noted use of said resort. This agreement will be constructed in accordance with and governed by the laws of the Province of Ontario.

### MYERS CAVE RESORT (MCR) RULES

Guests are required to take off their shoes before entering the Lodge, Suite or Cabins.

The Lodge, Suite and Cabin are SMOKE FREE. Guests are responsible for using the cans supplied to dispose of cigarette butts if smoking outside. MCR follows the Recycling Laws of the township of North-Frontenac, guests are required to use the recycling boxes as instructed and sort their garbage according to the posted signs. **All garbage and recycling must be kept in CLEAR BAGS ONLY. Guests are responsible for any damage to boats, jet-skis, furniture, buildings or property while at Myers Cave Resort. All damages will be charged to the Booking Guest's credit card or deducted from the security deposit.**

Guests must observe and obey all posted signs around the pool and spa. Maximum SPA capacity is 6 people – no person should spend more than 15 minutes in the spa as long exposure to hot water is a health hazard and should be avoided.

The booking guest is responsible to have all other guests (including visitors and late arrivals) sign the "Myers Cave Release of Claims" form.

**Please be advised that according to township By-Law there should be no excessive noise or loud music after 10 pm. Violation of this rule WILL result in a \$300 fine (Township By-Law Violation) and/or guests could be asked to leave MCR premises immediately.**
